State Awards \$6.2 Million in Alcohol/Drug Prevention Grants to 13 County ADAMH Boards

(Columbus, OH – April 11, 2011) The Ohio Department of Alcohol and Drug Addiction Services (ODADAS) announces community grants totaling more than \$1.8 million per year for the next three years from the federal Strategic Prevention Framework State Incentive Grant (SPF-SIG) to 13 Ohio county Alcohol, Drug Addiction and Mental Health (ADAMH) Boards. Originally funded by the Substance Abuse and Mental Health Services Administration (SAMHSA) Center for Substance Abuse Prevention in 2009, SPF-SIG is designed to help communities build culturally-competent, sustainable local infrastructure necessary to reduce the incidence of alcohol, illicit drug or prescription drug abuse among 18-25 year olds.

The 13 ADAMH board grantees were selected by ODADAS in a competitive process, following a two-year infrastructure development and planning stage at the state level. Phase One of the project has included needs assessment, capacity development and planning to begin implementation, which is the community level funding in Phase Two.

The County ADAMH Boards will administer funds on behalf of their counties' community coalitions. Coalitions are steering groups made up of law enforcement, faith-based organizations, the private sector, medical professionals, provider agencies, and young adults. Total allocations to the 13 grantees will average more than \$1.8 million a year for the next three years.

"The work accomplished through the Strategic Prevention Framework State Incentive Grant will be of tremendous benefit to the state of Ohio, its young adults, families, and local needs," remarked ODADAS Director Orman Hall. "The SPF-SIG process will allow communities to identify their unique needs and to pinpoint the risk and protective factors and resources that can be leveraged to reduce alcohol and other drug consumption levels."

The SPF-SIG process focuses on community needs assessment and development of environmental strategies known to be effective in substance abuse prevention. These strategies may include policy changes, legal climate, societal norms, media coverage, and access to alcohol/drugs, as opposed to the direct delivery of services to consumers. SPF-SIG funding will extend through June 30, 2014, with independent evaluation ongoing.
